PRESENTATIONS

3. Quarterly Investment Report for the Quarter ended September 30, 2023

Executive Director Tom Muir presented the Quarterly Investment Report ending September 30, 2023, noting the book value of this quarter's investments at \$3,895,594. The average quarterly yield was 5.08% with quarterly interest earnings of \$84,921.

4. Economic Development Report

Director of Planning and Development David Hawkins presented an update on current/future projects in the city.

- Azle Retail Development - 700 Blk FM 730N - there has been no activity on the items needed to complete the project. The 380 agreement expired in November 2023.
- Hornets Plaza - 1004 Boyd Rd - project is almost complete. The project is on track to meet the requirements of the 380 agreement. First tenant, Hornets Café, is under plan review.
- Kodiak Car Wash - 700 Boyd Rd - plan is for new car wash and self-storage units. Site plan is under review and owner intends to apply for a tree preservation ordinance appeal.
- Dutch Bros Coffee - 164 Industrial - building permit has been approved but has not been issued yet. Expect to break ground in 30–45 days.
- Community Caring Center - 317 Commerce St - 3,800 sq ft freezer/cooler box storage addition. Permit has been issued and they are working on the foundation.
- Urgent Care Facility - 133 E. Main St - Renovation of old 4,200 sq ft Azle Post Office building into a new Urgent Care Facility. Site plan and building permit under review.
- Stardust Spa and Salon - 342 NW Pkwy - Building permit approved 12-4-23. Site plan under review pending parking variance request presented to ZBA on 1-29-24.

Residential Developments

- Azle Grove Phase II (118 lot development) Lakeview Dr/N. Ash St - Site construction is complete. Building permits will be issued soon.
- Sandy Beach Addition (149 lot development) Sandy Beach Rd - Streets are being poured.

Community and Marketing Specialist Kristen Pegues presented the Economic Development Annual Report for 2023.
