Council may not comment publicly on non-agenda items, but may direct the City Manager to resolve the matter or request the matter be placed on a future agenda. Public comments regarding non-agenda items shall not include any "deliberation" as defined by Chapter 551 of the Government Code, as now or hereafter amended. If you have a subject that may require City Council action, you may obtain a form from the City Secretary and request the item be placed on a future agenda.

A RESOLUTION OF THE CITY OF AZLE, TEXAS CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD MAY 4, 2024 FOR THE PURPOSE OF ELECTING THREE (3) COUNCIL MEMBERS TO THE CITY COUNCIL OF THE CITY OF AZLE.

WHEREAS: Ordinance No. 2024-01 ordered the General Election that was held on Saturday, May 4, 2024, for the purpose of electing three (3) Council Members to Places 1, 2, and 5 for two (2) year terms or until their successors are duly elected and qualified; in the City of Azle, Texas; and

WHEREAS: said elections were duly and legally conducted by the Tarrant County and Parker County Elections Administrators as authorized by and in conformity with the election laws of the State of Texas and the City's Charter; and

WHEREAS: the results of said elections have been verified by Tarrant and Parker County Elections Administrators, Clint Ludwig and Crickett Miller respectively, and returned to the City Council; and

WHEREAS: it is hereby officially found and determined that the meeting at which this resolution was adopted was open to the public, and public notice of the time, place, and purpose of said meeting was given, all as required by Chapter 551 of the Texas Government Code.
