Ms. Beard was pleased to announce that TxDOT has approved funding of up to \$400,000 to enhance the intersection of SH 199 and FM 730 N. She presented landscape design models and noted that the City will cover the cost of engineering services. The Council was happy with the proposed designs and selected locations.
