**2. Chick-fil-a Mural / Artwork**

City Manager Amber Beard updated the Beautification Board that she contacted Chick-fil-A regarding a proposed exterior mural. Chick-fil-A advised that an exterior mural would not align with their brand standards, but offered an alternative of installing two framed custom artwork panels inside the dining room that would reflect the City of Azle.

The Board discussed possible themes and suggested two panels—one representing Azle ISD and one representing the City of Azle—using recognizable symbols similar to the provided example. Amber will contact the Azle ISD and see if they are on board, and send them some design ideas.

**3. Landscape Beautification Project at SH 199 & Boyd Rd**

Assistant City Manager Amber Beard updated the Board that the City is working with Westwood Professional Services, Inc. on the roadside amenity signage discussed at the previous meeting. Ms. Beard presented the proposed signage and advised that staff is checking on cost estimates, as the project is not eligible for funding through the Green Ribbon grant.

**4. Discussion of Projects and Programs**

The Board was informed that the City of Azle is now a Keep Texas Beautiful affiliate. The Board discussed placement of the affiliate sign and either Central Park or FeedLot.

The Board discussed potential mural options along the NW Parkway or SE Parkway under N. Stewart Bridge.

The Board was advised that April 2027 will mark the City of Azle's 70th anniversary. Special Events Coordinator Amanda Scott expressed interest in meeting with the Board to discuss celebration planning.

April 11, 2026, was identified as a tentative date for a citywide cleanup day.

City staff advised that the City plans to apply for the Green Ribbon Grant for 2027.
